## Bodylines fitness & wellness club terms & conditions:

#### 1. Membership Cards

- ✓ Members will be given a membership card and shall hand it into the club reception upon entering the club. The card shall be retained until the member departs the club. If a membership application is under process and a membership card has not been issued, a receipt will allow access
- ✓ If a member loses his/her card, this loss should be reported to the club immediately and another card shall be issued for a fee of 2 JOD.
- ✓ The management reserves the right to expel or terminate the membership of any member for any reason it deems appropriate. The cancellation of any membership may be without explanation and without returning the member's subscription or any part therefor.

#### 2. Registration

- ✓ Members, member's guests, hotel guests and guests shall sign in and print their name clearly in the registration sheet on arrival at the club reception and bring along an employment letter
- ✓ Members guests and guests will pay the appropriate fees at the club reception before using the facilities. Members are requested not to leave the club before their guests and are responsible for their good conduct and safety.
- ✓ All guests must observe the rules and regulations of the club
- ✓ The management reserves the right to refuse entry to any guest without reason or explanation.

## 3. Liability

- ✓ The management shall not be responsible or liable for any loss or damage to property whatsoever or any bodily injury, death or illness of any member and/or guest, however caused, sustained or incurred arising out of or in any way connected with the use, whether proper or otherwise, of any of the equipment and/or facilities, whether defective or not, of the club.
- ✓ The management will not be responsible for the death, injury, illness, or mental impairment of any member and/or guest whether known or unknown using the facilities.

#### 4. Safety & hygiene

- ✓ Members and guests are requested to abide by the following rules:
  - No personal food or beverage items will be allowed to be consumed on the premises
  - o Smoking is not allowed in the entire club
  - o No pets are allowed into the entire club
  - o Proper attire should be worn for all exercises
  - o Appropriate swimwear must be worn for all wet areas

#### 5. Operating hours & facility usage

- ✓ The gym opens from 6:00 AM until 10:00 PM daily
- ✓ The seasonal pools open from 8:00 AM until 6:00 PM daily
- ✓ The management reserves the right to close or re-schedule the timings of the recreational facilities as necessary

#### 6. Children

- ✓ The minimum age for membership of the club is 16 years old
- ✓ Children under the age of 16 must always be accompanied and supervised by an adult and they are not permitted to use the club facilities
- Children under the age of 12 that are using the pool facilities must always be accompanied by an adult
- ✓ Children are not allowed to use the gymnasium and wet areas

#### 7. Property

- ✓ Under no circumstances may any property of the club be removed from the premises
- ✓ The towel and locker key remain at the property of The Boulevard Arjaan by Rotana and must be returned after usage
- ✓ If a member loses his/her locker key, this loss should be reported to the club immediately and the member will have to pay a fee of 2 JOD

#### 8. Notice

✓ The club, at its discretion, may vary these rules and regulations at any time and shall make efforts to advice members and guests of all amendments and variations in advance.

## 9. Payment

- ✓ The Boulevard Arjaan by Rotana accepts cash payments and the following credit/debit cards: Visa, Mastercard, and American Express.
- ✓ The 1-year membership rate can be paid on two instalments, the first is paid upon joining and the second through signing a credit card authorization form while filling the membership form.
